The Philosophy stresses the importance of human development at all levels and also emphasizes the need to strengthen community's capacity to ensure a balanced way of life and resilience, with full respect for the environment. As an approach and mind-setting framework, we believe that SEP can be applied to all 17 SDGs. Therefore, over the recent years, Thailand has shared with international community the application of SEP, our home-grown approach to sustainable development.

Public Health, Climate Change, and Other topics related to Sustainable Development Goals (SDGs).

Course Objectives

This training course aims at sharing Thailand's experiences in applying Sufficiency Economy Philosophy (SEP) to community-based and economic development. At the end of this course, participants are expected to;

- Understand concept of Sufficiency Economy Philosophy (SEP) and its application for sustainable development.
- Understand linkage between SEP and economic concepts/theories.
- Understand how to apply SEP in community and economic development through case studies.
- Be able to apply monitoring and evaluation tools for SEP projects.
- Be able to apply SEP concept in the case of their respective countries.

- In-class participation.
- Advance assignment - Submission and presentation of "Country Report".
- Report - on a possible application of the SEP to their respective countries/territories.
- Project Assignment - Submission and presentation of group and individual project assignments.
- Reading Assignment - Thailand Review: Sufficiency Economy
- Attendance - Participants are required to attend all activities organized during the course. TICA reserves the rights to revoke its fellowship offered or take appropriate action

Course Outline

This training course focuses on application of Sufficiency Economy Philosophy (SEP) to community-based and economic development. Topics of the training are such as;

- Introduction to Sufficiency Economy Philosophy (SEP) theory and relevant economic theories;
- SEP in Community-based and Economic Development;
- SEP application in different economic settings;
- Monitoring and Evaluation tool for SEP projects;

Course Methodology

Training methodologies to be used during this training course include;

- Lecture;
- Group Discussion;
- Study visit.

Participant Criteria

Candidates must possess qualifications as specified in "Guideline for Thailand's Annual International Training Course Programme" No. 2 "Qualifications" and currently working with at least five-year experience in community/rural development or relevant fields.

Application

- Candidates must be nominated/ endorsed by their respective governments of the eligible countries/territories as well as Bahrain, Brunei Darussalam, Japan, Kuwait, Oman, Qatar, Republic of Korea, Russia, Saudi Arabia, Singapore and United Arab Emirates.
- Complete nomination documents must be submitted to TICA through the Royal Thai Embassy/ Permanent Mission of Thailand to the United Nations/Royal Thai Consulate-General accredited to eligible countries/territories.
