The Japan International Cooperation Agency (JICA) in Sri Lanka has invited nominations for the above Training Programme scheduled to be held in Japan from 08th February 2026 to 12th March 2026, with an online programme period from 02nd February 2026 to 06th February 2026. The details of the program, including the course description and application guidelines, are enclosed for your reference.

The objective of this training program is to equip human resources involved in hospital management in low-income and middle-income countries with the essential knowledge and skills required to enhance health and medical services. Through participation, individuals will develop the capacity to analyze and identify challenges and solutions in hospital management from a health systems perspective, and to systematically formulate these into concrete, actionable projects.

We are of the view that this programme presents a valuable opportunity, for the Ministry and the institutions under your preview, and could greatly benefit from participation. Therefore, we kindly request you to nominate suitable candidates for the program. These nominations will be submitted to the Government of Japan for final selection. Each nominee must meet the eligibility criteria and submit the following documents.

- For each of the nominee; two sets of duly filled Application Form for "JICA Knowledge Co-Creation Program" - New official Application Form can be downloaded from ERD public website (www.erd.gov.lk). Please note that hand written applications will not be accepted.
- Copy of the Nominee's English Score Sheet, if available (e.g. TOEFL, TOEIC, IELTS)
- Copy of the Passport (if available)
- Job Report: to be submitted with the application form. Fill in Annex VI, of this General Information 5.
- Duly filled ERD Form (Available at our website, www.erd.gov.lk)

The selected participants are also expected to represent Sri Lanka's national interests in a professional and consistent manner. Therefore, we would highly appreciate your support in identifying the most suitable and deserving candidates for this invaluable opportunity extended by JICA to the Government of Sri Lanka and we look forward to receiving a strong list of nominations.
